- \* April Brown from NAR reviewed 2013 Nat'l RPAC contributions and the process for 2014 contributions. A lot of discussion revolving around the Senate Race and all the collateral campaigns as a result.
- \* Approved a motion to request \$3,000 in Special Recognition funds from NAR to support Congressman Hank Johnson.
- \* Discussed potential Q4 RPAC Trustee Meeting for 2014 Election Cycle.
- \* Approved \$1,300 contribution to Insurance Commissioner Hudgens.
